

Application for CIE National Committee or CIE Associate National Committee

Members of the CIE are approved **National Committees** (NCs). A country seeking to join the Commission shall form, with the co-operation of organizations within that country having a special interest in light and lighting, one National Committee. This National Committee must submit evidence that it meets all the necessary requirements, and shall send its application to the Central Bureau. Approval of the application is decided by the CIE General Assembly (GA), which is comprised of the current CIE NCs.

As an alternative to full NC status, countries may also apply to join the CIE on a trial basis, as an **Associate National Committee** (ANC). Countries wishing to join CIE as an ANC must also submit evidence that they meet all necessary requirements. The application for ANC membership must be sent to the Central Bureau. Approval of the application is decided by the National Committees. This membership is granted for a four-year period, and may be renewed for one further four-year period according to the decision of the GA. An ANC may request membership as a National Committee at any time within the four-year period. An ANC may participate in the technical work of the CIE, may appoint a representative to attend the CIE GA and one Observer Member to each CIE Division, but shall have no voting rights, neither in administrative nor in technical matters.

In either case all applicants shall confirm that they have read and understood the **CIE Statutes and Bylaws**, these comprising statutory matters that by making the membership application they agree to.
